Recommended Pricing Options

Event Based Program

The Event Based Program is an exclusive three-year agreement and secures the lowest rates possible. Pilots agree to train annually, and each training session is billed as it is taken.

One-time Program

The One-time Program is designed for those owners who prefer to train on an annual basis without any additional commitment. Owners pay for each training session as it is scheduled.

General Provisions

- Preferred rates will be effective January 1, 2023 to December 31, 2025.
- POPA members enrolled on the Event Based Program must commit to a three (3) year term to receive the POPA preferred rates.
- Except as described here all normal benefits and provisions associated with the Event Based and One-time Programs apply.
- POPA members affiliated with Part 135 operations are not eligible to receive the POPA preferred rates.
- Program rates are to be paid in full prior to the beginning of the training event unless alternate arrangements have been approved.
- All rates are subject to escalation on each annual anniversary of the effective date of the training agreement. Rates will be adjusted by the percent increase, if any, set forth in the U.S. Government CPI-All Urban Consumers (CPI-U), not seasonally adjusted for the most recently available twelve-month period ending three months prior to the applicable effective-date anniversary.
